
ORDER MODIFYING MAXIMUM TRANSCRIPT FEE RATES

This court being advised that at its September 2007 session, the Judicial Conference of the U.S. Courts approved an increase of 10 percent to the maximum original and copy transcript fee rates to be effective in fiscal year 2008.

The Judicial Conference also approved a new rate for the delivery of transcripts within 14 days and agreed that the rate be set at the mid-point between rates authorized for expedited (7 days) and ordinary (30 days) delivery, to be effective in fiscal year 2008.

IT IS ORDERED that effective as of the signature date of this order, the District of Hawaii adopts the new Maximum Transcript Rates (attached) approved by the Judicial Conference of the U.S. Courts.

**Maximum Transcript Fee Rates - All Parties Per Page**

	<b>Original</b>	<b>First Copy to Each Party</b>	<b>Each Add'l Copy to the Same Party</b>
<b>Ordinary Transcript (30 day)</b> A transcript to be delivered within thirty (30) calendar days after receipt of an order.	\$3.65	\$ .90	\$ .60
<b>14-Day Transcript</b> A transcript to be delivered within fourteen (14) calendar days after receipt of an order.	\$4.25	\$ .90	\$ .60
<b>Expedited Transcript (7 day)</b> A transcript to be delivered within seven (7) calendar days after receipt of an order.	\$4.85	\$ .90	\$ .60
<b>Daily Transcript</b> A transcript to be delivered following adjournment and prior to the normal opening hour of the court on the following morning whether or not it actually is a court day.	\$6.05	\$1.20	\$ .90
<b>Hourly Transcript</b> A transcript of proceedings ordered under unusual circumstances to be delivered within two (2) hours.	\$7.25	\$1.20	\$ .90
<b>Realtime Transcript</b> A draft unedited transcript produced by a certified realtime reporter as a byproduct of realtime to be delivered electronically during proceedings or immediately following adjournment.	\$3.05	\$1.20
