## RE: REQUEST FOR PROPOSALS FISCAL YEAR 2023

Dear Program Administrator:

The United States Probation and Pretrial Services Office (USPPSO) for the District of Hawaii is soliciting proposals to provide treatment services for persons under supervision who are drug dependent, alcohol dependent, suffering from a psychiatric disorder, and/or in need of court-ordered sex offender treatment. The following is a list of service(s) we are soliciting:

Island of Oahu:

Substance abuse outpatient treatment - Central Oahu (0975-23-DAP-01C)

Substance abuse outpatient treatment - East Oahu (0975-23-DAP-01E)

Sex offender treatment (polygraph and maintenance monitoring) (0975-23-SOT-01B)

Integrated Treatment for Co-Occurring Services (includes telehealth services for Maui County) – Oahu (0975-23-CO-01)

Island of Maui:

Substance abuse outpatient treatment – Central Maui (0975-23-DAP-03)

Sex offender treatment (evaluation) (includes telehealth services for Molokai and Lanai) – Central Maui (0975-23-SOT-03A)

Sex offender treatment (counseling) (includes telehealth services for Molokai and Lanai) – Central Maui (0975-23-SOT-03C)

These individuals include persons on pretrial status, probation, supervised release, or parole, who are under the supervision of the USPPSO. This group could also include inmates in the U.S. Bureau of Prisons who are residing in the community, or in federal or contract community treatment centers.

The Request For Proposal (RFP) contains the full text of all applicable Government regulations, and all offerors are subject to the provisions contained in the RFP. In responding to the RFP, you should answer fully each item and supply all information requested. Section "L" provides specific directions for potential vendors in completing their proposals. The minimum standards for the services listed are contained in the Clauses and Terms of Agreement, and all proposals will be evaluated by the criteria identified in Section "M."

Proposals will be awarded on the basis of initial offers submitted, and each initial offer should contain your organization's best terms from a price and technical standpoint. There will be no additional opportunity to modify your proposal.

Please read the RFP carefully; do not rely on knowledge of previous RFPs, or knowledge of previous federal procurement procedures.

The estimated monthly quantity (EMQ) listed in Section "B" of the RFP is the estimate of the services to be provided during the term of this agreement. It is only an estimate. The EMQs may include telehealth services for neighbor island referrals.

Although the Government may choose to enter into a Blanket Purchase Agreement with multiple vendors, the Government reserves the right to award to a single vendor.

The term for this Blanket Purchase Agreement is twelve (12) months, with a provision that shall allow the Government to unilaterally extend the agreement for an additional two (2) years, at the Government's discretion.

A vendor must be capable of providing all services identified in Section "B" and within the geographic area identified in Section "B."

For all proposals, an original and two (2) copies must be received no later than **4:00 p.m. on August 12, 2022,** at 300 Ala Moana Blvd., Room 2300, Honolulu, Hawaii 96850. Please do **not resubmit a blank copy of the RFP** with the proposal. Page 3 July 8, 2022

All copies <u>must</u> be originally signed. A copy of the Blanket Purchase Agreement, Clauses and Terms of Agreement, should be retained by the vendor for their files. <u>Please do not submit</u> **proposals in binders or notebooks or with tabs**.

Proposals can also be submitted electronically via email (20MB max) to uspohi\_treatment@hip.uscourts.gov by the deadline noted above. Electronic proposals need to be originally signed, then scanned and emailed; or signed using a digital signature. If you do not get a confirmation receipt for the emailed proposal from our office, please call 808-541-3411.

In your review of the RFP requirements, if applicable, please note the **Local Needs section** for the modification to the Description/Statement of Work.

Vendors are authorized to utilize telehealth upon approval from USPPSO and/or upon request of USPPSO.

Please note that federal clients are to receive priority placement in the treatment programs, and a contractor's ability to discharge a federal client without the involvement of the Probation or Pretrial Services Officer is limited.
