The schedule will now include a page rate for contract reporters who provide rough drafts of transcripts for judges of this court. Contract reporters may invoice the court for rough draft transcript orders provided to the court on or after October 1, 2014.

IT IS ORDERED that the maximum fee rate per page for rough draft transcripts provided to judges of this Court by contract reporters is \$1.20. The complete fee schedule is attached herein.
